## **PART 2**

### **1 SWIMMING SCHOOL HOURS**

- 1.1 The Swimming School will be open from MONDAY to FRIDAY between 10:00 and 18:00.
- 1.2 There will be no lessons on Public Holidays and parts of the school holidays.
- 1.3 Holiday courses will be given during December holidays. These courses are optional.
- 1.4 Every lesson will be 20 minutes (once or twice a week).
- 1.5 We work on a term cycle, 12 of 24 lessons per term.
- 1.6 We can unfortunately not make up lessons if you were late, forgot the time, if the child has a play day or just for an odd reason. Lessons will only be made up if we receive a doctor's note or if the instructor is sick.

### **2 FEES**

One lesson per week:	R500.00 per month or R1300 per term per child
Two lessons per week:	R600.00 per month or R1600 per term per child
Registration fee:	R300 per child once off

- 2.1 The parent undertakes to pay a registration fee of R300. The registration fee is not refundable. If you should stop lessons for a while, parents have to pay registration fees again.
- 2.2 The parent undertakes to pay a monthly fee of R..... (amount is according to your choice above). The parent undertakes to always pay the monthly fee in advance **before or on the 5<sup>th</sup>** of every month.
- 2.3 The Swimming School has the right to increase the school fees every year. At least 15 days written notice will be given to parents. Parents will be informed about the increase and the date of which increased swimming fees are payable.
- 2.4 Payments can be done EFT, by cheque or cash. If cheque or cash payments are done, it can be placed in the envelope provided and posted in the postbox in the swimming area.

### **3 GENERAL**

- 3.1 No child may be left on the school grounds by the parent without supervision, before or after swimming hours. The school will not take responsibility for children outside normal swimming hours.
- 3.2 Children with contagious diseases may not attend the swimming lessons as stipulated by Health and Welfare Organization Laws.
- 3.3 The School will take all necessary safety precautions when the child is in the School's care. The Swimming School will however not be held responsible for any injuries and diseases that were beyond their control when the child was in the swimming instructors care.
- 3.4 The parent further agrees that there will be **no discount** on swimming fees during holiday periods (including December) or for any other reason, should the child not attend the lesson.
- 3.5 The parent further acknowledges that this contract cannot be ended without notice in terms of Part 3 hereof, even in circumstances where the child can no longer attend the School, because of ill health or other medical and/or psychological reasons.
- 3.6 Parents are requested to please let the School know in advance if the child can't attend the lesson. Lessons need to be attended on a regular basis for the child to develop.
- 3.7 No parents are allowed in the swimming area during lessons. This makes it very difficult for the instructor and the child to concentrate. Parents may look through the sliding doors.
- 3.8 We request that all the swimmers wear caps, as this prolongs the life of our pumps as well as for health/higiene reasons.

**PART 3  
STIPULATION OF THE LAW**

**1. TERM OF CONTRACT**

This contract is for an indefinite period and can only be terminated if:

- 1.1 The Swimming School has the right to refuse admittance of the child to the Swimming School for any reason in terms hereof, or if any of the rules of the Swimming School are not obeyed by the parent, to end this contract immediately without prior notice of reasons and/or to end this contract with one calendar month's written notice.
- 1.2 The parent fails to pay the monthly swimming fees on time and the Swimming School therefore doesn't have to let the parent know by written notice of its intention.
- 1.3 The parent will be entitled to end this contract should the parent give **one calendar month's** notice. The parent further acknowledges that the contract can only be terminated by **written notice**, even if the reason is based on medical reasons, unforeseen moving or transfers, increase in school fees in terms of paragraph 2.3 of Part 2 hereof and other similar reasons.
- 1.4 The parent undertakes for as long as this contract is valid, to let the school know immediately by written notice of any address changes or other important information.

**2. GENERAL**

- 2.1 This contract is binding
- 2.2 No changes to this contract are valid unless it is put into writing and is signed by both parties.

**3. COSTS**

The parent undertakes to pay all legal costs that may arise in the process of recovering outstanding debts to the school. The parent owing the school will pay all lawyers fees and other fees. The parent is responsible for all costs.

- 4. The parent's signature on this contract is an acknowledgement that the parent act on behalf of both parents, or the natural guardian of the child, or the supervisory parent of the child, irrespective of which parent signs this contract.
- 5. I hereby waive any claim which I may have against Snipper-Snip Swimming School or any of the employees for any damage, sustained by any person which may arise in connection with tuition by Snipper-Snip Swimming School or any of its employees, whether such damage arise as a result of theft, lost of life, bodily injury or any other cause whatsoever. This waive is unconditional and is given in my personal capacity as a father/mother/legal guardian of any minor concerned.
- 6. I, the undersigned understand and will be submissive to the attached rules and above indemnity.
